SUMMARY DESCRIPTION OF BUSINESS

What is our business?

The Corporation is a Montreal-based mineral exploration company focused on grassroots exploration for hard rock lithium deposits in Eastern Canada, a critical metal necessary to global decarbonization and energy transition. The Corporation is rapidly advancing the most extensive grassroots lithium property portfolio in Canada with holdings in Québec, Ontario, Saskatchewan and Manitoba.

Recent Developments

On June 6, 2022, the Corporation announced the start of its 2022 lithium exploration campaign in Eastern Canada. Prospecting teams were deployed in the Abitibi region (Pontiac Project) and on the North Shore Project (near Johan Beetz Bay) in Québec, the Catamaran Projects in New Brunswick and the SMB Project in Nova Scotia.

On June 14, 2022, the Corporation announced the acquisition of additional pegmatite fields in the James Bay region of Québec. A total of approximately 810 claims, separated into 22 blocks and totaling 42,892 hectares, were staked and are collectively known as the James Bay Lithium Project.

On October 3, 2022, the Corporation announced that it has staked multiple claim groups near Hearst Ontario, totaling 60 claims and 26,318 hectares in an area that is highly prospective for lithium pegmatites. The Corporation has also optioned a spodumene-bearing pegmatite adjacent to the new project (Decoy and Moskito pegmatites) that contains up to 5.15% Li2O in historical chip samples. The entire Hearst portfolio includes 226 claims and covers 29,805 hectares.

On November 10, 2022, the Corporation announced that it has signed an option agreement with Midland Exploration Inc. (TSX-V: MD) to acquire a maximum 85% interest in potential LCT (lithium-cesium-tantalum) mineralization of the Mythril and Elrond properties, located in the James Bay region of Québec.

On November 28, 2022, the Corporation announced that it has signed an option agreement with Osisko Development Corp. (TSX-V: ODV) ("**ODV**") to acquire a 90% interest in the Anatacau Property located in the James Bay-Eeyou Istchee region of Québec and which is host to lithium mineralization. The Corporation further announced, on December 5, 2022, that it has expanded the option agreement with ODV to also acquire a 90% interest in the PLEX Project also located in the James Bay-Eeyou Istchee region of Québec. This transaction remains subject to TSXV's review and approval.

On December 22, 2022, the Corporation closed flow-through private placements and raised an aggregate of \$5,500,000 in gross proceeds to advance its Canadian portfolio.

On January 17, 2023, the Corporation announced the staking of a package of pegmatites in Saskatchewan and Manitoba totalling over 135 S-type pegmatites measuring a minimum of 500 meter strike length. On January 30, 2023, the Corporation also announced an option to acquire a 100% interest in the Hanson Lake pegmatite field, also in Saskatchewan, which contains several spodumene bearing pegmatites which have never been drilled.

On January 24, 2023 the Corporation announced the Mirage project which consists of an option agreement with Globex Mining Enterprises Inc. and a number of staked claims. The project is centered on a trail of large, angular spodumene bearing glacial boulders. The large size of the boulders, their quantity and angular nature suggest a proximal source. Furthermore, compilation work indicates that the overall claim group hosts lithium lithogeochemical anomalies above 100 ppm Li in altered basalts suggesting local alteration from influx of lithium rich fluids. No exploration work for lithium has been done in the area, and the majority of the claim group is located up-ice from the glacial boulders.

Material Facts

There are no material facts about the securities being distributed that has not been disclosed elsewhere in this offering document or in any other document filed by the Corporation in the 12 months preceding the date of this offering document.

The Underwriters have an option, exercisable in full or in part, up to 48 hours prior to the closing of the Offering, to purchase for resale up to an additional 1,764,705 Units at the Offering Price, for additional gross proceeds of approximately \$1,500,000 (the "**Underwriters' Option**").

Concurrent to the Offering, the Corporation will also issue up to 2,352,941 additional Units at the Offering Price, for additional gross proceeds of approximately \$2,000,000 as part of a non-brokered private placement (the "**Private Placement**").

Securities issued under the Additional Offering, the Underwriters' Option and the Private Placement will be subject to a hold period in Canada ending on the date that is four months plus one day following their issuance.

What are the business objectives that we expect to accomplish using the available funds?

The Corporation intends to use the proceeds raised from the Offering for exploration of the Corporation's projects in Québec, Ontario, Saskatchewan and Manitoba, and to increase its working capital.
